## **REMUNERATION FOR SUNDAY SUPPLIES**

**EFFECTIVE 1/1/11 the remuneration for Sunday Supplies will be \$122.00 which is .3% of Presbytery's minimum salary for 2010 (\$40,640); travel reimbursable at the IRS rate.**

The Committee on Ministry has stipulated that no Sunday Supply may serve the same congregation more than twice a month without a request by the session and approval granted by the Committee on Ministry.

The Committee on Ministry reminds congregations and ministers that when a minister is asked to moderate a session where he/she is not the pastor, this is considered part of his/her obligation to the Presbytery. However, it is up to the congregation receiving the services of a moderator, who is not the congregation's pastor, to reimburse the moderator for mileage (at the current IRS rate).

## **REMUNERATION FOR SUNDAY SUPPLIES LEADING TWO SERVICES**

The minimum compensation rate for Sunday Supplies leading two services on the same Sunday is set at one and one-third (1.333) times the rate for a single service, plus round-trip travel at the current IRS rate. (Example: The remuneration for one service beginning 1/1/11 is \$122. Therefore, the rate for two services would be \$163) [Equal payment for two churches or \$81.50 per service.]
